PLEASE READ CAREFULLY THIS POLICY IS STRICTLY ADHERED TO.

Youth Singers of Calgary registration Fees are charged based on a complete season but do not reflect the entire cost of the program. Volunteer and/or fundraising commitments may be a requirement of registration (see package). Please note ***that a portion of your registration fee and all administration fees are non-refundable.***

We accept payment in the form of cash, debit, cheque, money order, VISA, or MasterCard (we do not accept any other credit card). All fees are due upon registration but for an added administration fee you may choose one of two payment plans, OAC. Payment plans must have the down payment and administration fee payable at registration and accompanied by post-dated cheques or post-dated VISA or MASTERCARD vouchers for the balance of the payments.

When a participant withdraws from the program a refund will be available based on the following conditions:

1. All debts and accounts must be paid and up to date;
2. All fundraising commitments must be completed or paid out (see registration package for buy-out options); and
3. All items belonging to Youth Singers of Calgary must be returned complete and undamaged.

Refund calculations begin from the date that the office has been notified of a singer's withdrawal. Refunds will not be issued until the above conditions 1 through 3 have been complied with. Should the above conditions not be met within (30) thirty days of your withdrawal, the cost of all commitments and unreturned items will be charged to your account and any refunds due will be applied to the outstanding debt prior to issuing a cheque, in case of a credit balance or an invoice in case of a debit balance. Following are refund and payment schedules:
